## TESTING

The next section consists of a summary of well test results by the New Mexico Environmental Department and one Nitrate test from the Water Store. Notice the changes in Nitrates, Sulfates and the pH.

There are two before and after tests with our product on contaminated wells, one with high sulfate levels and one with excessive iron, sulfates and salts notice the improvement of all levels for both wells tests to an acceptable level for all parameters tested with one treatment of PZ Water.
